The addition of a conviction for Conveying Contraband onto Prison Grounds has been added as an excludable offense. In addition, if the inmate's placement in IPP is not in the Department's best interests, he or she may be excluded. Health screening will be limited to certain classifications of inmates being considered for Community Service Intensive Program Prisons. The privately managed prison's contact monitor or designee has been added for consistentcy with existing language.
