The new legislation clarifies the process for filing a petition for a certificate of qualification of employment based on whether the individual lives inside or outside of the state, allows the department of rehabilitation and correction to establish criteria to allow for early applications for a certificate of qualification for employment, and changes the information that the petition shall include from the name or type of each collateral sanction for which the individual is requesting a certificate of qualification

The rule's changes clarify the process for filing a petition for a certificate of qualification of employment based on whether the individual lives inside or outside of the state, establish criteria to allow for early applications for a certificate of qualification for employment, and change the information that the petition shall include from the name or type of each collateral sanction for which the individual is requesting a certificate of qualification for employment to a general statement as to why the individual has filed the petition and how the certificate would assist the individual.
