- (H): The inmate and/or family of the inmate shall bear responsibility for the cost of escorting the inmate to the bedside or private funeral viewing.

(H): The cost shall be determined by the mileage for the trip, based on the current mileage compensation established by the department of administrative services for state agencies.

(H): Staff compensation shall not be a part of the cost.

(H): During the escort the inmate shall remain under the constant supervision of an employee of the department.
