The rule requires some updates to reflect changes in hospital operations.

The rule establishes procedures for the funding and operation of OhioMHAS's regional psychiatric hospital (RPH) commissaries. The changes are as follows:

1. Clarifies that patient assigned to work in an RPH will, like hospital employees, have their salaries or wages paid from appropriated funds.

2. Specifies that the commissary cash journal, not form DMH FIS 032, will be used to substantiate all charge sales at the commissary.

- 3. Requires RPHs, before seeking bids from local suppliers for items to sell in RPH commissaries, to determine whether the needed items are available from requisite purchase programs specified in Ohio Department of Administrative Services policy PM-01. Associated with this change, requires the form that the OhioMHAS deputy director must approve to be accompanied with verification that this was done.
- 4. Requires bids from local suppliers to be obtained at least annually using formal (rather than informal) procedures.
- 5. Makes stylistic changes to reflect drafting standards in LSC's Rule Drafting Manual.
