This rule defines the Community Psychiatric Supportive Treatment (CPST) service and also identifies what it is not, e.g., it is not a day treatment, partial hospitalization, intensive outpatient, or developmental or educational service or program. It also more clearly articulates requirements for provision of the service that are within the limits of related state and federal policies, rules and regulations.

This rule also describes how providers may provide the CPST service via real-time interactive videoconferencing. If utilizing real-time interactive videoconferencing, providers must assure that the equipment used has sufficient speed and resolution to assure quality and must further assure the security of the connection to provide for confidential communication.
