# Appendix A Ohio Department of Mental Health IHBT Consumer Outcomes Thresholds

#### I. Introduction

The purpose of this appendix is to explain the requirements of collecting and scoring Consumer Outcomes data for clients receiving IHBT services, as well as establishing the Outcomes Thresholds referenced in rule 5122-29-28 of the Administrative Code.

#### II. Outcomes Matrix and Individual Client Thresholds
