The rule establishes general requirements governing provision of and payment for Adult Day Support, Career Planning, Group Employment Support, Individual Employment Support, Non-Medical Transportation, and Vocational Habilitation provided to individuals enrolled in Home and Community-Based Services waivers administered by the Department. The rule is being amended to make clear that the budget limitations in Appendix B apply only to services provided under the Individual Options Waiver, align wording with newer rules, and update a citation to an administrative rule.

The rule requires county boards of developmental disabilities to ensure an Acuity Assessment Instrument is completed for each individual receiving an adult day service,

assign the individual to groups for purposes of provision of services, determine the individual's budget limitations, authorize payment for services, communicate information about these processes and outcomes to individuals being served, and assist individuals to request administrative review by the Department. The rule requires providers of Adult Day Support, Group Employment Support, and Vocational Habilitation to ensure and document that sufficient staff are engaged in provision of the services. These activities consume staff resources, the cost of which varies by county board of developmental disabilities/provider based on multiple factors (e.g., number and nature of individuals served, number of staff employed, and staff wages and benefits) and is unknown by the Department.

Prior state level review shall not be required for the initiation and/or changes in services that can occur within the budget limitation resulting from a revision to the individual service plan that has been agreed to by an individual through the individual service plan process.

5123-9-19 ELIMINATED PARAGRAPH (F)(2):

When the annual cost for adult day support, career planning, group employment support, individual employment support, and/or vocational habilitation exceeds the assigned budget limitation, the service and support administrator shall inform the individual of his or her right to request an administrative review to obtain adult day support, career planning, group employment support, individual employment support, and/or vocational habilitation services that result in a new group assignment and budget limitation that exceeds the budget limitation determined initially by the county board in accordance with paragraph (C) of this rule.
