The Department is amending the rule to permit Participant-Directed Homemaker/ Personal Care to be provided to an individual in an acute care hospital, increase payment rates effective January 1, 2024 and July 1, 2024, correct citations to the Administrative Code, and align wording with newer rules.

The rule defines Participant-Directed Homemaker/Personal Care and sets forth provider qualifications, requirements for service delivery and documentation of services, and payment standards for the service. The Department is amending the rule to permit Participant-Directed Homemaker/Personal Care to be provided to an individual in an acute care hospital, increase payment rates effective January 1, 2024 and July 1, 2024, correct citations to the Administrative Code, and align wording with newer rules.

House Bill 33 of the 135th General Assembly increased the Department's appropriations by approximately \$352 million in fiscal year 2024 and \$860 million in fiscal year 2025 to fund increases in the payment rates for most services provided to persons enrolled in Department-administered Home and Community-Based Services waivers. The impact of the payment rate increases is not projected for each specific service because the impact will depend on the volume of each service to be used, which is unknown at this time.

13. What are the estimated costs of compliance for all persons and/or organizations directly affected by the rule?

The rule requires a person or agency seeking approval to provide Participant-Directed Homemaker/Personal Care to submit an application and have a Medicaid provider agreement with the Ohio Department of Medicaid. The rule requires a provider of services to maintain service documentation. These activities consume applicant/provider resources, the cost of which varies by applicant/provider and is unknown to the Department.

5123-9-32 (B)(12): Minutes of service delivery time accrued throughout a day shall be added together for the purpose of calculating the number of fifteenminute billing units for the day.

5123-9-32 (B)(25): "Service documentation" means all records and information on one or more documents, including documents that may be created or maintained in electronic software programs, created and maintained contemporaneously with the delivery of services, and kept in a manner as to fully disclose the nature and extent of services delivered that shall include the items delineated in paragraph (E) of this rule to validate payment for medicaid services.

5123-9-32 (C)(1): Participant-directed homemaker/personal care provided to an individual enrolled in the individual options waiver or the level one waiver shall be provided by a common law employee.

5123-9-32 (C)(4): Neither a county board nor a regional council of governments formed under section 5126.13 of the Revised Code by two or more county boards shall provide participant-directed homemaker/personal care.

5123-9-32 (C)(5)(b): A common law employee need not complete the eight hours of annual training described on page two of appendix A to rule 5123-2-09 of the Administrative Code unless specifically required to do so by the individual receiving services, but in any case shall annually complete training in accordance with standards established by the department in:

5123-9-32 (C)(6): A provider of participant-directed homemaker/personal care shall not administer medication or perform health-related activities unless the provider meets the applicable requirements of Chapters 4723., 5123., and 5126. of the Revised Code and rules adopted under those chapters.

5123-9-32 (C)(7): An applicant seeking certification to provide participant-directed homemaker/ personal care shall will complete and submit an application through the department's website (http://dodd.ohio.gov).

5123-9-32 (C)(8): The individual receiving participant-directed homemaker/personal care shall determine training to be completed by the common law employee or staff of the agency with choice as necessary to meet the individual's unique needs.

5123-9-32 (D)(4): A provider of participant-directed homemaker/personal care shall not also provide money management or shared living to the same individual.

5123-9-32 (D)(5): Participant-directed homemaker/personal care shall not be provided to an individual at the same time as residential respite.

5123-9-32 (D)(6): Participant-directed homemaker/personal care services involving direct contact with an individual receiving the services shall not be provided at the same time the individual is receiving adult day support, group employment support, individual employment support, or vocational habilitation.

5123-9-32 (D)(9): A provider shall not bill for participant-directed homemaker/personal care provided by the driver during the same time non-medical transportation at the per-trip rate is provided.

5123-9-32 (D)(10): The ratio of persons providing participant-directed homemaker/personal care to the individuals being served shall not exceed one to three.

5123-9-32 (D)(11): A provider of participant-directed homemaker/personal care shall arrange for substitute coverage, when necessary, only from a provider certified or approved by the department and as identified in the individual service plan; notify as applicable, the individual or legally responsible person in the event that substitute coverage is necessary; and notify the person identified in the individual service plan when substitute coverage is not available to allow such person to make other arrangements.

5123-9-32 (D)(12): A provider delivering participant-directed homemaker/personal care in accordance with this rule, excluding on-site/on-call, shall

utilize electronic visit verification in accordance with rule 5160-1-40 of the Administrative Code.

5123-9-32 (E)(2): A common law employee shall prepare an accurate timesheet to be verified by the individual receiving participant-directed homemaker/personal care prior to submission to the financial management services entity.

5123-9-32 (F)(2): The payment rates for participant-directed homemaker/personal care provided by a common law employee shall be negotiated by the individual and the common law employee subject to the minimum and maximum payment rates contained in the appendix to this rule and shall be recorded in the individual service plan.

5123-9-32 (F)(2): The payment rates for participant-directed homemaker/personal care provided by a common law employee shall be negotiated by the individual and the common law employee subject to the minimum and maximum payment rates contained in the appendix to this rule and shall be recorded in the individual service plan.

5123-9-32 (F)(3): The payment rates for participant-directed homemaker/personal care shall be adjusted to reflect the number of individuals being served and the number of persons providing services.

5123-9-32 (F)(6)(b): The duration of the complex care rate modification shall be limited to the individual's waiver eligibility span, may be determined needed or no longer needed within that waiver eligibility span, and may be renewed annually.

5123-9-32 (F)(7): The team shall use a department-approved tool to assess and document in the individual service plan when on-site/on-call may be appropriate.

5123-9-32 (F)(7)(a): In making the assessment, the team shall consider:

5123-9-32 (F)(7)(b): A provider shall be paid at the on-site/on-call rate for participant-directed homemaker/personal care contained in the appendix to this rule when:

5123-9-32 (F)(7)(c): During an authorized on-site/on-call period, a provider shall be paid the routine participant-directed homemaker/personal care rate instead of the on-site/on-call rate for a period of time when an individual receives supports.
