The rule rule establishes minimum qualifications through certification standards that shall apply to persons, directly providing or supervising the provision of Service and Support Administration, who are employed by county boards of developmental disabilities and entities under contract with county boards of developmental disabilities to provide or supervise the provision of Service and Support Administration.

supervise the provision of service and support administration. Issuing certification requires staff resources, the costs of which vary based on the number of certifications issued and the wages paid to staff who carryout the function.

A Superintendent may recoup costs by requiring applicants for Service and Support Administration certification to pay an application fee. The application fee for Service and Support Administrator certification may not exceed \$50. The application fee for Service and Support Administration Supervisor certification may not exceed \$75.
