Pending CMS approval, the new service will be added to the PASSPORT waiver, effective 1/1/2017. The addition of the new service is projected to increase aggregate spending in the current biennium by approximately \$32,142,362 (all funds).

Personal Care Service Maximum Reimbursement

The proposed rate changes for the personal care rate change are projected to increase aggregate spending by approximately \$11,499,794(all funds)in the current biennium.

Waiver Nursing Service Maximum Reimbursement

ODM is proposing a rate increase for the second half of SFY 2017 for nursing services available through the Medicaid State Plan and HCBS waivers, including
