This rule is being proposed for amendment to implement policy directives resulting from the redesign of Medicaid behavioral health services, a joint collaboration between the Ohio Department of Medicaid (ODM), the Ohio Department of Mental Health and Addiction Services, and the Governor's Office of Health Transformation. This is a Medicaid rule therefore ODM is responsible for this amendment.

This rule sets forth the provider reimbursement policies for Medicaid covered community mental health services including the health home program. This rule is being proposed for amendment to continue the current provider reimbursement policy for phase one of the health home program which was set to expire on July 1, 2015. This proposed revision is currently in place as a result of an emergency filing of this rule. The specific change is in paragraph (H)(3).
