The language was added to the following:

Paragraph B(2)(c)(iv) "May make referrals for physical therapy services under the MSP component of the medicaid program as authorized in section 5162.366 of the Revised Code ."

Paragraph B(3)(c)(iv)"May make referrals for speech-language pathology services under the MSP component of the medicaid program as authorized in section 5162.366 of the Revised Code ."

Paragraph B(4)(c)(ii) "May make referrals for audiology services under the MSP component of the medicaid program as authorized in section 5162.366 of the Revised Code."

Paragraph C(1)(2)(3)(a)(b)(c) new language was added to include who can refer for services in accordance with section 5162.366 of the Revised Code.
