OAC 5160-43-08 rules govern the criteria for billing and receipt of payment from the Ohio Department of Medicaid for Recovery Management Service billed using the T1016 billing code. The modifications will allow alignment with similar Home and Community Base Service program billing formats. The proposed changes are as follows:

5160-43-08 (A) (2) - The maximum number of reimbursable 15-minute units of service billable per month will be 8.5 units.

5160-43-08 (C) Column 3, unit rate â## The 15-minute unit rate reimbursement is being adjusted from \$19 per unit to \$27.54 per unit reimbursement.
