This rule describes the ways in which an individual enrolled on an ODM-administered waiver has choice and control over the arrangement/direction of his or her home and community-based waiver services, and the selection and control over the direction of the providers of those services. For example, the individual and/or authorized representative shall: decide who, besides themselves, shall participate in the development of the all services plan and all plans of care; communicate to providers personal preferences about duties, tasks and procedures to be performed; work with the case management agency and providers to identify and secure additional training to meet the individual's specific needs; and participate in the recruitment, selection and dismissal of providers. The rule also sets forth case management requirements that must be met in order to assure the individual's health and welfare while exercising his or her right to choice and control.
