This rule is being proposed for amendment for the purpose of increasing the reimbursement rate for personal care tasks performed as part of the home care attendant service available under the Ohio Home Care Waiver, and codifying overtime rates and billing procedures for the base rate and personal care tasks performed as part of the service. It is also being proposed for amendment to comply

with five-year review.

Pursuant to the Executive Budget, the Ohio Department of Medicaid (ODM) undertook a redesign of the rate-setting methodology for aide services available through the Medicaid State Plan and home and community-based service (HCBS) waivers, including home care attendant services furnished under the Ohio Home Care Waiver. The redesign took into account labor market data, education and licensure status of providers, whether providers are independent or home health agencies, and the length of time of service visits. The new rate setting methodology and rates for home care attendant services were implemented in August 2015 (SFY 16).

With this proposed amendment, ODM is adjusting the methodology and proposing a rate increase for the second half of SFY 17 for personal care aide services under the Ohio Home Care Waiver. This includes the personal care aide tasks furnished as part of the home care attendant service under the waiver. It is estimated this proposed rate increase for all personal care aide services under the Ohio Home Care Waiver will increase expenditures for the agency during the current biennium by \$1,569,835 (all funds).
