This rule is being proposed for amendment to update policy relating to the administration of the OhioRISE program.

Page 2 Rule Number: **5160-59-02**

This rule is proposed for amendment to increase the length of time an individual is enrolled in the OhioRISE program from five hundred forty-five days to two years before assessing if the individual needs to be disenrolled (unless they reach the maximum age for the program). This will allow for additional time to serve the individual in the program prior to considering disenrollment. This rule has been updated to allow disenrollment from the program after three hundred and sixty-five days if they have not experienced an inpatient stay in a hospital. This rule has added an Ohio Administrative Code (OAC) rule reference 5160-59-03.6 to align with the addition of the Psychiatric Residential Treatment Facility (PRTF) rule to Chapter 5160-59 of the Administrative Code. This rule adds a clarification on an already existing Medicaid eligibility policy. A rule update has been made to replace "plan" with "program". Lastly, there is a deleted paragraph to align operationally with the OhioRISE program and reduce administrative burden.
