The amendments change #primary taxpayer# to #reporting person,# incorporate changes from House Bill 508 of the 129th General Assembly, and state an increase in the CAT rate from .06% to .26% to reflect the actual CAT rate rather than the phase-in rate that was in use when the rule was originally written.
