Rhodes State Office Tower, 30 East Broad Street, Columbus, Ohio 43215. All interested persons affected by the proposed actions may be heard by oral or written testimony.

The following rules are being **rescinded** and new ones proposed:

123:1-49-01 Equal Employment Opportunity Policy.

This rule is the state equal employment opportunity policy that prohibits discrimination based on federal and state regulation and laws and within state government concerning employment related decisions.

123:1-49-02 Duties of the State Employees Equal Opportunity Coordinator.

This rule states the duties of the state EEO Coordinator as well as added information from the previous section of a rule that the EEO Coordinator shall review and evaluate agency equal opportunity program operations periodically, obtain such reports as the coordinator deems necessary, and report to the Governor.

123:1-49-03 Responsibilities of State Agencies in Regard to EEO.

This rule states the responsibilities for the agencies when implementing equal employment opportunity policies within their respective agency. Additional responsibilities have been included and moved section 123:1-49-05, Characteristics Of An Affirmative Action Program-- to provide agency head with relevant information, to evaluate programs, eliminate discrimination, report unequal practices and counsel aggrieved employees.

123:1-49-04 Establishment of Affirmative Action Plan.

This rule states that each agency shall establish, maintain, and carry out a continuing Affirmative Action Plan designed to promote equal opportunity in every aspect of agency personnel policy and practice.

123:1-49-05 Characteristics of Affirmative Action Plan.

This rule provides information about the agency affirmative action plan as well as how the agency should appraise operations to ensure conformity with these regulations.

123:1-49-06 Adoption of EEO Commission Guidelines (Rescission) Filing of Complaint (New).

This rule provides guidance on the procedures for filing a complaint, complainant's rights, and jurisdictional requirements of the equal opportunity division.

123:1-49-07 Division Review (Rescission) Appeal to Division (New).

This rule gives individual guidance of steps to take after investigation and ruling on the merits of a complaint and the complainant's rights in order to appeal the determination of an agency.

123:1-49-08 Filing and Presentation of Complaints (Rescission) Hearing (New).

This rule gives guidance on when, where, and how a hearing can be held. It also provides guidance on witnesses, reports and recommendations.
