

**NOTICE OF PUBLIC HEARING**

**NOTE ON ELECTRONIC HEARING:** To reduce the spread of the novel coronavirus (the virus that causes COVID-19) and pursuant to section 12 of Am. Sub. H.B. No. 197, the Department of Administrative Services is conducting this hearing virtually through electronic means. These rule actions are occurring as the result of the five-year review of the existing rules governing the Minority-owned Business Enterprise (“MBE”) and the Encouraging Diversity, Growth and Equity (“EDGE”) business development programs, and the need to enact rules governing the newly created Women-owned Business Enterprise program (“WBE”).

The new rules are a single set of rules that govern all three programs. The existing EDGE and MBE rules are being rescinded and replaced by this new chapter, even though many current provisions are being carried forward. The goal in revising the existing rules as well as in creating the rules for the WBE program has been to have consistency in the regulation of all three programs. Another goal was to strengthen the agency's ability to ensure that certified businesses perform a commercially useful function and are not simply pass-thru entities that allow non-eligible individuals or businesses to receive the economic benefits of the certification. The Agency also seeks to improve its ability to conduct business compliance reviews during the entire certification period to ensure that certified businesses remain in compliance with all rules throughout the entire certification time period.
