Changes to this rule will fix grammatical errors.

123:5-3-06 Annual meeting.

Changes to this rule will fix grammatical errors.

123:5-3-09 Updating procurement list: adding an item to the procurement list.

Changes to this rule will fix grammatical errors.

123:5-3-10 Selection of qualified nonprofit agencies.

Changes to this rule will fix grammatical errors.

123:5-3-12 Monitoring the purchasing activities of a government ordering office.

Changes to this rule adds language to recommend a list of agencies not complying with the law over the past year be submitted to the director of administrative services.

The following rule is being **rescinded** and a new one proposed:

123:5-3-07 Specification authority.

This rule establishes guidelines for preparing specifications for procurements of supplies and services. It is being filed as new because more than 50% of the current rule is being altered.
