## NOTICE OF INTENTION TO AMEND AND HOLD A PUBLIC HEARING ON STATE OF OHIO SOIL AND WATER RESOURCES RULES

Administrative Rules 1501:15-5-01 thru 1501:15-5-18 are being amended in accordance with the five year rule review required for state agency rules. The proposed changes update language references, streamline enforcement procedures, and establish flexibility in the Agricultural Pollution Abatement Program to implement best management practices. Administrative Rules 1501:15-5-19 and 1501:15-5-20 are being adopted to enable the designation of a distressed watershed and require a nutrient management plan for certain operations within a designated distressed watershed.

A public hearing on the proposed amendments and adoption of these rules will be held at 10:00 am on Monday, November 8, 2010 at the Ohio Department of Natural Resources'

Assembly Center, 2045 Morse Road, Building E, 1<sup>st</sup> Floor, Columbus, Ohio 43229.
