SUMMARY:

- Administrative rules 1501-8-03 and 1501:1-1-02 are being amended to correct the name of the Division of Parks and Watercraft.
- Administrative rule 1501:46-15-13 is being amended to mirror Division of Wildlife rule regarding waterfowl blind permits and will allow the public to participate in a blind drawing without a requirement to be present at the park on the date and time of the scheduled drawing.
 All other Administrative rules listed are being amended to adopt one or more of the following technical changes:
 - Update the Revised Code sections that are implemented or amplified by the rule as well as update the Revised Code section that provides the Division with rule adoption authority.
 - Correct references to other renumbered sections of the Ohio Administrative Code.
 - Remove gender-specific pronouns.
 - o Correct capitalized text that no longer conforms to Administrative Code conventions.
 - o Replace the term "park officer" with "natural resources officer".

A public hearing on the proposed amendments or rescission and replacement of these rules will be held online at 2:00 p.m. on Thursday, June 3^{rd} , 2021. The hearing will be held virtually in response to directives from the Ohio Department of Health and Governor Mike DeWine. Any person affected by the proposed rule may present their comments by utilizing the 'ask a question' feature.
