**PUBLIC HEARING
ON PROPOSED AMENDMENTS TO
RULES OF PROCEDURE**

As required by Rule 1509-1-25 of the Ohio Administrative Code and Chapter 119. of the Ohio Revised Code, the Oil & Gas Commission hereby makes public notice of a public hearing on fourteen proposed rule amendments. The hearing will take place on **June 28, 2018, at 10:00 a.m.**, at the Ohio Department of Natural Resources, Fountain Square Complex, 2045 Morse Road, Building E, Assembly Center West Conference Room, Columbus, Ohio 43229.

The proposed amended rules are Rules 1509-1-01, 1509-1-02, 1509-1-03, 1509-1-04, 1509-1-06, 1509-1-08, 1509-1-09, 1509-1-15, 1509-1-18, 1509-1-19, 1509-1-22, 1509-1-23, 1509-1-25 and 1509-1-26. These rules are part of the Oil & Gas Commission's Rules of Procedure.

The amendments are proposed in order to establish a fair, orderly and efficient review process before the Oil & Gas Commission, and address the following areas:
