PUBLIC HEARING ON PROPOSED AMENDMENTS TO RULES OF PROCEDURE

As required by Rule 1509-1-25 of the Ohio Administrative Code and Chapter 119. of the Ohio Revised Code, the Oil & Gas Commission hereby makes public notice of a public hearing on two proposed rule amendments. The hearing will take place on **December 10, 2018, at 10:00 a.m.**, at the Ohio Department of Natural Resources, Fountain Square Complex, 2045 Morse Road, Building E, Assembly Center West Conference Room, Columbus, Ohio 43229.

The proposed amended rules are Rules 1509-1-14 and 1509-1-24. These rules are part of the Oil & Gas Commission's Rules of Procedure. The amendments are proposed in order to establish a fair, orderly and efficient review process before the Oil & Gas Commission, and address the following areas:

1509-1-14 Intervention, Participation by Amicus Curiae 1509-1-24 Appeals from Commission Decisions

At the public hearing, any person affected by the adoption of the proposed amended rules may appear and be heard in person, by an attorney, or both, and may present testimony orally or in writing, offer and examine witnesses, and present evidence tending to show that the proposed amended rules, if adopted, will be unreasonable or unlawful.
