PUBLIC HEARING ON PROPOSED AMENDMENTS TO RULES OF PROCEDURE

As required by Rule 1509-1-16 of the Ohio Administrative Code and Chapter 119. of the Ohio Revised Code, the Oil & Gas Commission hereby makes public notice of a public hearing on the rescission of seventeen existing rules and the proposal of twenty-six new rules addressing procedures before the Oil & Gas Commission. The hearing will take place on July 25, 2008 at 9:00 a.m., at the Ohio Department of Natural Resources, Fountain Square Complex, 2045 Morse Road, Assembly Center East Conference Room, Building E, 1st Floor, Columbus, Ohio 43229.

The rules proposed to be rescinded are rules 1509-1-01 through 1509-1-17 of the Administrative Code, and constitute the existing Rules of Procedure of the Oil & Gas Commission. These rules will be replaced by proposed new Rules of Procedure.

The proposed new rules are Rules 1509-1-01 through 1509-1-26 of the Administrative Code.

The new rules are being proposed in order to establish an orderly review procedure before the Oil & Gas Commission, and to aid and assist litigants who appear before the Commission. The proposed new rules address the following areas:
