## Legal Notice

The State Board of Education will hold a public hearing regarding the rule actions listed below, on February 10, 2020, at 8:30 a.m., in room 102 at the Ohio Department of Education, 25 South Front Street, Columbus, Ohio, 43215:

### OAC Chapter 3301-20: Standards for Employment of Individuals with Criminal Convictions (1 rule)

- **3301-20-02** Circumstances upon which individuals with certain convictions may participate in OhioReads program. (Rescind)

This rule amplified Ohio Revised Code (ORC) 3301.88, which was repealed under House Bill 477 of the 132nd General Assembly, effective April 8, 2019.

### OAC Chapter 3301-25 Educational Aide Permits (7 rules)

- **3301-25-01** One-year educational aide permit. (Amend)
- **3301-25-02** Renewal of one-year educational aide permit. (Rescind)
- **3301-25-03** One-year student monitor educational aide permit. (Amend)
- **3301-25-04** Renewal of the one-year student monitor educational aide permit. (Rescind)
- **3301-25-05** Four-year educational aide permit. (Amend)
- **3301-25-07** Renewal of the four-year educational aide permit. (Rescind)
- **3301-25-08** Validity of educational aide permits. (Amend)

These rules are being amended to provide greater clarity and to align with language contained in statute. Further, three of the rules, pertaining to permit renewals, are being rescinded and incorporated into the language of other existing rules for better comprehensive understanding of how the rules function.

### OAC Chapter 3301-28 Local Report Card (1 rule)

- **3301-28-06** Value-added progress dimension (Amend)

In House Bill 166, the 133rd General Assembly amended the requirements for the value-added progress dimension. The proposed revision in this rule reflects this new requirement.

Additionally, Ohio Revised Code Section 3302.03, as amended by House Bill 166, requires the Board to “prohibit the assigning of a grade of ‘A’ for that measure unless the district’s or building’s grade assigned for value-added progress dimension for all subgroups under division (C)(1)(f) of this section is a ‘C’ or higher.” The proposed revision in this rule reflects this new requirement.

#### OAC Chapter 3301-83 Pupil Transportation (8 rules)

- **3301-83-05** Administration. (Amend)  
The amendment to this rule adds language regarding the Department's role in performing official timings on behalf of school districts.
- **3301-83-06** Personnel qualifications. (Amend)  
This rule is being amended to 1) align with Ohio law, 2) clarify qualification requirements, and 3) add language to allow deaf drivers employed by the Ohio School for the Deaf and Ohio State School for the Blind to transport individuals in vehicles other than school buses, such as vans.
- **3301-83-07** School transportation driver physical qualifications rule. (Amend)  
The rule is being amended to clarify requirements for medical examinations and update the list of individuals permitted to conduct medical examinations.
- **3301-83-08** Pupil transportation management policies. (Amend)  
This rule is being amended to require school districts to adopt policies and procedures for pupil transportation management and to clarify current requirements that must be included in a school district's policy.
- **3301-83-10** Personnel training program. (Amend)  
The amendments include 1) removing language that was intended to enhance the rule but deemed unnecessary by stakeholders and 2) removing language that allowed drivers with unexpired pre-service certificates to apply for a temporary certificate.
- **3301-83-11** School bus inspections. (Amend)  
This rule is being amended to require a post trip inspection and reorganize the inspection requirements, as requested by stakeholders.
- **3301-83-13** School bus routes and stops. (Amend)  
This rule is being amended to require school districts to adopt policies and procedures for bus stop locations and add requirements currently outlined in OAC 3301-83-20/ General Rules.
- **3301-83-20** General rules. (Amend)  
This rule is being amended to remove the two requirements that were added to OAC 3301-83-13/ School Bus Routes and Stops.
