# OAC Chapter 3302-24-29 Temporary Military Duty License (1 Rule)

OAC 3302-24-29 establishes a three-year temporary military duty license. This rule is being amended to reflect legislative changes stemming from House Bill 33 of the 135th General Assembly (HB 33).

## OAC Chapter 3302-25-01 One-Year Educational Aide Permit (1 Rule)

OAC 3302-25-01establishes a one-year educational aide permit that may be issued upon the request and recommendation of an employing superintendent of a city, local, exempted village, or joint vocational school district, educational service center, or the governing authority of a chartered nonpublic school or community school. This rule is being amended to reflect legislative changes stemming from House Bill 33 of the 135th General Assembly (HB 33).

### OAC Chapter 3302-25-03 One-Year Student Monitor Educational Aide Permit (1 Rule)

OAC 3302-25-03 establishes an initial one-year student monitor educational aide permit that may be issued upon the request and recommendation of an employing superintendent of a city, local, exempted village, or joint vocational school district, educational service center, or the governing authority of a chartered nonpublic school or community school. This rule is being amended to reflect legislative changes stemming from House Bill 33 of the 135th General Assembly (HB 33).

#### OAC Chapter 3302-25-05 Four-Year Educational Aide Permit (1 Rule)

OAC 3302-25-05 establishes a four-year educational aide permit may be issued upon the request and recommendation of the employing superintendent of a city, local, exempted village, or joint vocational school district, educational service center, or the governing authority of a chartered nonpublic school or community school. This rule is being amended to reflect legislative changes stemming from House Bill 33 of the 135th General Assembly (HB 33).

#### OAC Chapter 3302-25-08 Validity of Educational Aide Permits (1 Rule)

OAC 3302-25-08 establishes an initial one-year educational aide permit shall be valid only in the employing school or district that requested the issuance of the permit. This rule is being amended to reflect legislative changes stemming from House Bill 33 of the 135th General Assembly (HB 33).
