THIS NOTICE OF PUBLIC HEARING ANNOUNCES OOD'S INTENTION TO FILE PROPOSED AND AMENDED FOUR EXISTING CHAPTER 1 RULES IN ACCORDANCE WITH CHAPTER 119 AND CHAPTER 111 OF THE OHIO REVISED CODE. THE REASON FOR FILING THE PROPOSED RULES ARE TO CLARIFY AND UPDATE RULE LANGUAGE, AND TO REFLECT OUR NEW AGENCY NAME.

THE PURPOSE OF THIS HEARING IS TO PROVIDE THE OPPORTUNITY FOR ANY INTERESTED PERSON TO GIVE TESTIMONY FOR OR AGAINST THESE PROPOSED OHIO ADMINISTRATIVE CODE RULES. TESTIMONY FOR THE PROPOSAL OR AGAINST IT MAY BE MADE EITHER AT THE PUBLIC HEARING OR IN WRITING TO THE EXECUTIVE DIRECTOR BEFORE THE PUBLIC HEARING. QUESTIONS ABOUT THESE RULES WILL NOT BE ENTERTAINED AT THE PUBLIC HEARING, BUT MAY BE ADDRESSED TO THE EXECUTIVE DIRECTOR EITHER BEFORE OR AFTER THE PUBLIC HEARING.

A COPY OF THE FULL TEXT OF THE PROPOSED RULES AND A COPY OF THIS PUBLIC NOTICE SHALL BE AVAILABLE FOR REVIEW, FREE OF CHARGE, AT THE OOD EXECUTIVE DIRECTOR'S OFFICE.
