CLARIFY RSC'S JURISDICTION OVER AND TIMELINE THE AUDIT FINDINGS FOR FILING ΤO FINDINGS, **OBJECTIONS** SUCH UPDATE Α CLASSIFICATION OF MINORITY VENDORS. CLARIFY THE USE OF THIRD-PARTY PAYMENTS FOR SERVICES LISTED IN RSC FEE SCHEDULES, AND CODIFY THE VR CLOSURE PROCESS.

THE PURPOSE OF THIS HEARING IS TO PROVIDE THE OPPORTUNITY FOR ANY INTERESTED PERSON TO GIVE TESTIMONY FOR OR AGAINST THE PROPOSED AMENDMENTS OF OHIO ADMINISTRATIVE CODE RULES. TESTIMONY FOR THE PROPOSALS OR AGAINST THEM MAY BE MADE EITHER AT THE PUBLIC HEARING OR IN WRITING TO THE EXECUTIVE DIRECTOR BEFORE THE PUBLIC HEARING.
