PUBLIC HEARING NOTICE

Pursuant to Chapter 119 of the Ohio Revised Code, the Ohio State Board of Career Colleges and Schools will conduct a Public Rules Hearing on Wednesday, November 14, 2018, at 10:30 a.m. The location of the hearing will be 30 East Broad Street, 29th Floor, Room 2925, Columbus, Ohio, 43215.
