A public hearing will be conducted on September 18, 2009 at the Frank J. Lausche Building, 615 W. Superior Avenue, Cleveland, Ohio 44113, at 11:00 A.M. in accordance with the Administrative Procedures Act, (Chapter 119, Ohio Revised Code). Any person affected by the proposed action may appear and be heard at the hearing in accordance with Section 119.03(C), Ohio Revised Code.


