Pursuant to section 119.03 of the Ohio Revised Code, the Superintendent of Insurance, State of Ohio, will hold a public hearing at 10:00 a.m., on Monday, September 30, 2024, at the Ohio Department of Insurance, Public Hearing Room, 50 West Town Street, 3rd Floor, Suite 300, Columbus, Ohio, to consider the rescission and promulgation of Ohio Administrative Code sections:

The purpose of rule 3901-2-02 is to define certain terms as used in Chapter 3901-2 of the Administrative Code.

Rule 3901-2-02 is being reviewed as part of the agency five-year rule review. Rule is being rescinded to new per the fifty per cent filing guidelines. The proposed amendments will add purpose, authority and severability paragraphs to bring the rule into compliance with standard department rule formatting.

The purpose of rule 3901-2-03 is to identify specific rules that apply to solicitations subject to Chapter 3901-2 of the Administrative Code.

Rule 3901-2-03 is being reviewed as part of the agency five-year rule review. Rule is being rescinded to new per the fifty per cent filing guidelines. The proposed amendments will add purpose, authority and severability paragraphs to bring the rule into compliance with standard department rule formatting.

The purpose of rule 3901-2-06 is to set forth the manner in which information should be presented in a form of proxy, proxy statement, or solicitation subject to Chapter 3901-2 of the Administrative Code.

Rule 3901-2-06 is being reviewed as part of the agency five-year rule review. Rule is being rescinded to new per the fifty per cent filing guidelines. The proposed amendments will add purpose, authority and severability sections to bring the rule into compliance with standard department rule formatting; as well as make technical amendments and remove regulatory restrictions.

The purpose of rule 3901-2-07 is to identify the form of proxy, proxy statement, or solicitation material that should be filed with the superintendent of insurance when such form of proxy, proxy statement, or solicitation material is subject to Chapter 3901-2 of the Administrative Code.

Rule 3901-2-07 is being reviewed as part of the agency five-year rule review. Rule is being rescinded to new per the fifty per cent filing guidelines. The proposed amendments will add purpose, authority and severability sections to bring the rule into compliance with standard department rule formatting, as well as make technical amendments.

The purpose of rule 3901-2-09 is to identify the manner in which a proponent may present to security holders a proposal in a form of proxy or proxy statement that is subject to Chapter 3901-2 of the Administrative Code.

Rule 3901-2-09 is being reviewed as part of the agency five-year rule review. Rule is being rescinded to new per the fifty per cent filing guidelines. The proposed amendments will add purpose, authority and severability sections to bring the rule into compliance with standard department rule formatting; as well as make technical amendments and remove regulatory restrictions.

The purpose of rule 3901-2-10 is to prohibit false or misleading statements from a proxy statement, form of proxy, notice of meeting, information statement, or other communication subject to Chapter 3901-2 of the Administrative Code.

Rule 3901-2-10 is being reviewed as part of the agency five-year rule review. Rule is being rescinded to new per the fifty per cent filing guidelines. The proposed amendments will add purpose, authority and severability sections to bring the rule into compliance with standard department rule formatting, as well as make technical amendments and remove a regulatory restriction.

The purpose of rule 3901-2-11 is to prohibit any person from soliciting an undated or postdated proxy statement that is subject to Chapter 3901-2 of the Administrative Code.

Rule 3901-2-11 is being reviewed as part of the agency five-year rule review. Rule is being rescinded to new per the fifty per cent filing guidelines. The proposed amendments are technical for department rule formatting purposes and will reduce regulatory restrictions.

The purpose of rule 3901-5-02 is to establish the procedure to review insurance continuing education provider applications.

The purpose of rule 3901-5-04 is to establish criteria, standards and procedures for providers of continuing education (CE) programs.

Rule 3901-5-04 is being reviewed as part of the agency five-year rule review. Rule is being rescinded to new per the fifty per cent filing guidelines. The proposed amendments are technical and will reduce regulatory restrictions as well as improve understanding of the rule requirements.
