NOTICE OF PUBLIC HEARING

Notice is hereby given that the Board of Building Standards will convene for a public hearing in accordance with Chapter 119. of the Revised Code, at 10:00 A.M., Friday, November 7, 2008 in Hearing Room #1, at 6606 Tussing Road, Reynoldsburg, Ohio, 43068. The purpose of the hearing is to consider rules of the Administrative Code, identified as Amendments Group LXXXI of the Ohio Building Codes, proposed pursuant to Chapters 119., 3781., 3791., and 4104. of the Revised Code.

building official on a stop work order, and to make the text of sections 117.3 and 117.4.2 reflect current procedures; **4101:1-3-01** to add "or space" after building in section 303.1, exception #1 and to add note "q" to Table 307.1(1); **4101:1-9-01** to fix incorrect code references in sections 903.2.7 and Table 903.2.13, to add a period in section 903.2.9, to italicize the variables in section 909.5, and to add the word "the" in section 911.1; **4101:1-11-01** to fix incorrect references in sections 1109.7 and 1110.2, item 5; **4101:1-29-01** to change the text within the R-1 row and to add a water closet fixture requirement in the R-3 row of Table 2902.1; and **4101:1-35-01** to delete the references to the 2003 IECC and the 2005 NFPA 70 for one-, two-, and three-family dwellings.

PART E

Consider the following amended rules of the Ohio Mechanical Code: **4101:2-12-01** to add requirements in sections 1203.16, Table 1202.4. and Table 1202.5 for polypropylene piping; and **4101:2-15-01** to add a reference to ASTM F 2389 and to delete the reference to the 2005 NFPA 70 for one-, two-, and three-family dwellings.

PART F

Consider the following amended rules of the Ohio Plumbing Code: **4101:3-4-01** to add a lavatory requirement to the I-4 row of Table 403.1 and to clarify the enforcement intent in section 403.6; and **4101:3-13-01** to delete the reference to the 2005 NFPA 70 for one-, two-, and three-family dwellings.

PART G

Consider the following amended rule of the Boiler and Pressure Vessel rules: **4101:4-10-01** to allow the superintendent of the division of industrial compliance to approve certain automated, electronic control and monitoring systems for certain steam boilers and steam engines.
