The Amendments of the following rules:

- **4121-1-01 Notice procedure for the adoption, amendment or rescission of rules.**
The OIC is proposing the amendment of Ohio Adm.Code 4121-1-01 to provide the public with access via the internet to proposed rule adoption, amendment or rescission of rules.
- **4121-1-02 Notice of public meetings.**
The OIC is proposing the amendment of Ohio Adm.Code 4121-1-02 to provide requestors the ability to receive notice of Industrial Commission meetings via electronic mail.
- **4121-1-03 Non-adjudicatory meetings of the industrial commission.**
The OIC is proposing the amendment of Ohio Adm. Code 4121-1-03 to clarify the Industrial Commission's discretion to conduct regular meetings as well as update the process for the keeping of minutes utilizing current technological advancements.
- **4121-3-01 Office locations, office hours, and scope of rules.**
The OIC is proposing the amendment of Ohio Adm. Code 4121-3-01 to be consistent with the updated emergency clause contained within the updated Industrial Commission teleworking policy.
