Pursuant to section 4141.13 and Chapter 119. of the Ohio Revised Code, the Director of the Ohio Department of Job and Family Services gives notice of the department's intent to consider the amendment, rescission or adoption of the rules as identified below and to hold a public hearing thereon.

Rule 4141-1-04, entitled <u>Limited partnership associations</u>, limited partnerships and <u>limited liability companies</u>, is being proposed for rescission and replacement because amending the existing rule would alter more than fifty percent of its text. The new rule 4141-1-04 is being proposed for adoption to clarify the circumstances under which a limited partner of a limited partnership or limited partnership association, or a member of a single or multi-member limited liability company, would be in covered employment under Revised Code Chapter 4141.

Rule 4141-9-14, entitled <u>Retroactive pay awards</u>, defines what a retroactive pay award is, how such awards may be allocated, and how adjustments to remuneration as a result of such awards are to be processed. The amendment would specify that an employer may not deduct payments made under Chapter 4141. from a back pay award when the back payments are made for the same weeks as the unemployment compensation payments.

Rule 4141-11-10, entitled <u>Voluntary payments</u>, provides the procedure for contributory employers to make voluntary payments. The amendment would provide employers an additional option for making such payments.

Rule 4141-11-28, entitled <u>Definition of "best interest of the unemployment compensation fund,"</u> explains when and under what circumstances a reduction in the amount of interest, forfeiture, and fines may be permitted under Chapter 4141. The amendment makes no substantive change and merely corrects the spelling of a single word in the rule.
