Pursuant to section 4141.13 and Chapter 119.03 of the Ohio Revised Code, the director of the Ohio Department of Job and Family Services gives notice of the department's intent to consider the amendment of the rules as identified below and of a public hearing thereon. The rules below are proposed to be amended as a result of the five year review process.

OAC Rule 4141-1-04 entitled "Limited partnership associations, limited partnerships and limited liability companies". This rule defines limited partnership associations, limited partnerships and limited liability companies pertaining to unemployment insurance.

OAC Rule 4141-5-03: entitled "Family relationships." This rule defines which wages of family members cannot be excluded from unemployment insurance tax reports.

OAC Rule 4141-5-06: entitled "Major nontenured policymaking or advisory positions." The rule defines the taxable wages of nontenured or advisory positions.

OAC Rule 4141-11-28: entitled "Definition of 'best interest of the unemployment compensation fund'." The rule explains what constitutes "best interest."

OAC Rule 4141-15-06: entitled "Determining when an employer's account is chargeable for benefits." This rule determines the time frame when an employer's account is chargeable for unemployment insurance benefits.

OAC Rule 4141-35-05: entitled "Charges on combined wage credit claims paid by Ohio." This rule determines how unemployment insurance benefit charges are pro-rated on combined wage claims.
