Chapter 4167 of the Administrative Code contains the rules governing the Public Employment Risk Reduction Program ("PERRP"). The mission of PERRP is to ensure public employees in Ohio have safe and healthful working conditions. PERRP is distinct from the program operated by OSHA, which covers only private sector employees. PERRP provides compliance assistance to public employers and investigates reports of unsafe working conditions.

Twenty-five of the twenty-seven rules contained in Chapter 4167 of the Administrative Code are subject to five-year rule review under R.C. 119.032. These twelve Chapter 4167 rules are due for review January 1, 2024.
