In accordance with the provisions of section 119.03 and 119.032 of the Ohio Revised Code, the Liquor Control Commission intends to amend, create and/or rescind the following rules and offers the following synopses of the rules:

| Rule Number 4301:1-1-05 | The current version of this rule is being rescinded and a new version proposed which establishes requirements for the sale of "mixed beverages", including wine.  |
| Rule Number 4301:1-1-11 | This rule is being amended to include all classes of quota permits, and to clarify the procedure for processing applications on file with the Division of Liquor Control when the quota in a particular taxing district is filled.  |
| Rule Number 4301:1-1-12 | The current version of this rule is being rescinded and a new version proposed concerning the actions to be taken by the Division of Liquor Control before issuing a permit. The changes are technical in nature.   |
| Rule Number 4301:1-1-14 | This rule is being amended to clarify provisions of the rule. The Commission is proposing to delete the language in the rule dealing with expansion and diminution of a permit premises and allow for the Division of Liquor Control to promulgate a rule in regards to this language under the authority granted to the Division in R.C. 4301.10(C). The Commission is also deleting the language that refers to "immediate" family members in paragraph (A)(8). |
| Rule Number 4301:1-1-15 | This rule is being amended for technical changes and to include limited liability companies.  |

Rule Number 4301:1-1-16	This rule is being amended for technical changes.
Rule Number 4301:1-1-17	This rule is being amended for technical changes and to clarify the sanitation requirements for a freestanding building on an enclosed shopping center's tract of land.
Rule Number 4301:1-1-20	This rule is being amended for technical changes.
Rule Number 4301:1-1-21	This rule is being amended to provide technical clarity for the rule provisions.
Rule Number 4301:1-1-32	The current version of this rule is being rescinded and a new version proposed to clarify the requirements for samples.

In accordance with section 119.03 and 119.032 of the Ohio Revised Code, the proposed rules are subject to review and comment. At this public hearing, any person interested may appear on their own behalf, with counsel, or may be represented by counsel, and may offer evidence and give testimony with respect to the advisability or necessity in behalf of or against this rule.
