The Ohio Department of Public Safety, Ohio State Highway Patrol ("OSHP"), will conduct a public hearing for the purpose of soliciting comments on the following rules proposed for adoption to Chapter 4501-33 "Self-Assembled Motor Vehicle Inspections" and 4501-41 "Transparent, Nontransparent, Translucent, and Reflectorized Window Materials" of the Ohio Administrative Code. These rules are being filed pursuant to a completed five-year rule review in accordance with section 119.032 of the Revised Code.

4501-33-05 (Equipment inspection for self-assembled motor vehicles) provides an explanation of the equipment inspection for self-assembled motor vehicles. This rule is proposed for amendment to strike the reference to an OSHP internal form (HP-106) in paragraph (B) and delete paragraph (C) in its entirety as Ohio Revised Code and Ohio Administrative Code sections are exempt from compliance with sections 121.71 to 121.74 of the Revised Code pertaining to materials incorporated by reference.

4501-33-06 (Equipment inspection for salvage motor vehicles) provides an explanation of the equipment inspection for salvage motor vehicles. This rule is proposed for amendment to strike the reference to an OSHP internal form (HP-106) in paragraph (B) and delete paragraph (C) in its entirety as Ohio Revised Code and Ohio Administrative Code sections are exempt from compliance with sections 121.71 to 121.74 of the Revised Code pertaining to materials incorporated by reference.

4501-41-03 (Specifications) sets forth specifications for the use of transparent, nontransparent, translucent, and reflectorized materials on windows of vehicles. This rule is proposed for amendment to update the website address where material incorporated by reference may be accessed.

4501-41-04 (Manufacturer's certification) sets forth requirements for a manufacturer's certification and label regarding compliance with the luminous reflectance and light transmission specifications of Chapter 4501-41 of the Administrative Code when the material is used in conjunction with safety glazing materials of motor vehicle windshields and/or windows. This rule is proposed for amendment to update the website address where material incorporated by reference may be accessed.

4501-41-05 (Exemptions) sets forth exemptions from the requirements of Chapter 4501-41 of the Administrative Code. This rule is proposed for amendment to update the website address where materials incorporated by reference may be accessed.

Any persons affected by the proposed adoption of these rules may appear at the hearing and be heard in person, or by an attorney, or both, or may present their position, argument, or contention in writing. Persons may offer and examine witnesses and present evidence to show that the proposed rules will be unreasonable or unlawful if enacted.
