NOTICE OF PUBLIC HEARING

Acting under the authority of the Ohio Revised Code Sections 119.03, the Ohio State Cosmetology and Barber Board hereby announces a public hearing will be held Monday, March 18, 2019, at 9:00 a.m. in the Board Room, 1929 Gateway Circle, Grove City, Ohio. This is a statement of the agency's intention to promulgate the following rules:

New Rules

• 4713-1-06: Medical facilities offering cosmetology services.

Purpose: This rule replaces current rule 4713-1-06 and addresses salon licensing requirements when cosmetology services are being offered at a medical facility under the prescriptive, delegated, or direct care of a medical professional practicing within their scope of practice.

• 4713-11-06: Storage of chemicals.

Purpose: This rule replaces current rule 4713-11-06. The newly proposed rule proposes to add barber shops and simplifies chemical storage by stating chemical used to practice barbering and cosmetology shall be stored in a location that is not accessible to customers or the public.

Amended Rules

• 4713-11-01: Application for operation of beauty salon.

Purpose: This rule is being proposed to clarify the application requirements for salons. The rule establishes that salons will apply for licensure on forms approved by the board, pay the applicable, non-refundable fee, and indicate that the salon cannot provide services until the license has been approved.

• 4713-11-09: Exhaust fumes from service areas.

Purpose: This rule is proposed to be amended to add barber shops to the rule requirements. The rule establishes that salons and barber shops must be equipped with proper commercial exhaust fans or air filtration that is compliant with local or state commercial building code.

• 4713-11-11: Glamour photography services.

Purpose: This rule is proposed to be amended to add barbering to the rule requirements and to clarify that persons performing cosmetology or barbering services in conjunction with glamour photography services must hold a valid license for the barbering or branch of cosmetology service being performed.

Rescinded Rules

• 4713-1-06: Cosmetologist must be licensed in Ohio.

Purpose: This rule is proposed to be rescinded and replaced with a new rule. The current rule reiterates provisions of law that require persons engaged in cosmetology and tanning services to hold an Ohio license. The rule also addresses medical facilities that provide esthetic services. Reiteration of law is not necessary, and the subject of esthetic services provided in medical facilities is not addressed in the rule title. For this reason, the Board is proposing to rescind the rule and replace it.

• 4713-11-06: Cosmetological substance storage.

Purpose: This rule is proposed to be rescinded and replaced with a new rule. The reason for rescinding the current rule is due to the amount of added and deleted language. As a result, the rule must be rescinded and reintroduced as a new rule.

• 4713-11-07: Display of sign.

Purpose: This rule is proposed to be rescinded, because it references another rule and it is unnecessary.
