

The public hearing of the above proposed changes to the State Board of Cosmetology rules will be conducted on Tuesday, April 8, 2003 beginning at 2:00 p.m. The hearing will be held at the Board Offices, 3700 South High Street, 101 Southland Mall, Columbus, Ohio 43207, and from time to time thereafter as may be required by the Board to hear all relevant testimony, oral or written, by any person affected by the proposed action, his/her attorney, or both.

The new and amended Chapter 11 rules modify salon requirements for restrooms, signage, dispensary, application, glamour photography and other Ohio professional board licensees working in a salon. Chapter 13 rule makes minor changes to the independent contractor rule for clarity. Chapter 15 rules revise disinfection requirements, allow food in a salon, establish new equipment sanitation procedures and massage room usage. The Chapter 19 rules modify the minimum age for tanning without parental consent to 18

years of age and make a minor change in cracked tanning bed cover requirements. The Chapter 21 rules have been modified to allow Internet and correspondence based CE courses. The full text of the proposed rules will be available on the Board of Cosmetology's website, <u>www.state.oh.us/cos</u> and at the Register of Ohio website <u>http://www.registerofohio.state.oh.us/</u>. All interested persons will be given an opportunity to be heard. Those persons who wish to provide oral testimony at the hearing are encouraged to inform the Board prior to the hearing date and may be given preference in the order of their testimony. Persons interested in providing written testimony may direct them to the attention of James R. Rough, Director, Ohio State Board of Cosmetology, 101 Southland Mall, Columbus, Ohio 43207. Written comments must be received by the Board of Cosmetology Office before the close of the hearing record.

Copies of the proposed Rules will be on file with the Secretary of State, the Legislative Service Commission, and the Joint Committee on Agency Rule Review, at least thirty days prior to the public hearing, and are available at the State of Ohio Board of Cosmetology Offices at the aforementioned address.
