NOTICE OF PUBLIC HEARING**

The **State Medical Board of Ohio**, pursuant to Chapter 119, Ohio Revised Code, hereby gives notice that it will conduct a public hearing to consider the rescission, amendment, and adoption of rules.

The public hearing will be conducted on **July 24, 2018, at 1:30 p.m. in the Lobby Hearing Room, Rhodes State Office Tower, 30 E. Broad St., 1st Floor, Columbus, OH**. Oral or written testimony may be presented by any person affected by the proposed actions.
