Pursuant to sections 5103.03, 5101.141, 5153.166, 3107.031 and Chapter 119 of the Ohio Revised Code, the director of the Ohio Department of Job and Family Services gives notice of the department's intent to consider the amendment of the rules as identified below and of a public hearing thereon.

## OAC rule 5101:2-42-18.1 entitled Non-Discrimination Requirements for Foster Care

Placements explains that race, color, or national origin (RCNO) may not be considered in the placement process for foster care. It outlines what is prohibited and permitted when selecting a foster care placement. It also details the steps that need to be taken should RCNO become a compelling factor in the placement process. In paragraph (J)(2) language was edited to comply with the CSI project to identify outdated Ohio Administrative Code methods of communication and ORC terms that require in-person interaction. The revision dates for forms were removed throughout.

OAC rule 5101:2-48-13 entitled Non-Discrimination Requirements for Adoptive Placements

explains that RCNO may not be considered in the placement process for an adoptive placement. It outlines what is prohibited and permitted when selecting an adoptive placement. It also details the steps that need to be taken should RCNO become a compelling factor in the placement process. Paragraph (F) was replaced, as the requirements were obsoleted per Procedure Letter No. 325 in January 2018. In paragraph (M)(2) language was edited to comply with the CSI project to identify outdated Ohio Administrative Code methods of communication and ORC terms that require in-person interaction. The term "SACWIS" was changed to "Ohio SACWIS." The revision dates for forms were removed throughout.
