Rule 5101:3-45-04, entitled ODJFS-administered waiver program: provider enrollment process, sets forth the provider enrollment process for the Ohio Department of Job and Family Services (ODJFS)-administered waiver service providers. This rule is being amended to comply with the forthcoming implementation of ODJFS Medicaid Information Technology Systems (MITS). Changes to the rule include new language in paragraph (B) "The waiver provider application shall be completed and submitted in accordance with the requirements set forth in Chapter 5101:3-1 of the Administrative Code."

Rule 5101:3-46-06, entitled Ohio home care waiver: reimbursement rates and billing procedures, sets forth the provider enrollment process the Ohio home care waiver reimbursement rates and billing procedures. This rule is being amended to comply with the forthcoming implementation of ODJFS Medicaid Information Technology Systems (MITS). Changes to the rule include this addition to paragraph (F) "Claims shall be submitted to, and reimbursement shall be provided by, the Ohio department of job and family services in accordance with Chapter 5101:3-1 of the Administrative Code" and this deletion in paragraph (F) "Reimbursement will be provided with paragraph (A) to (D) of rule 5101:3-1-60 of the Administrative Code." No changes are being proposed to the reimbursement rates.

Rule 5101:3-47-06, entitled Transitions MR/DD waiver program: reimbursement rates and billing procedures, sets forth the reimbursement rates and billing procedures. This rule is being amended to comply with the forthcoming implementation of ODJFS Medicaid Information Technology Systems (MITS). Changes to the rule include addition to paragraph (F) "Claims shall be submitted to, and reimbursement shall be provided by, the Ohio department of job and family services in accordance with Chapter 5101:3-1 of the Administrative Code" and deletion in paragraph (F) "Reimbursement will be provided with paragraph (A) to (D) of rule 5101:3-1-60 of the Administrative Code." No changes are being proposed to the reimbursement rates.

Rule 5101:3-50-06, entitled Transitions carve-out waiver program: reimbursement rates and billing procedures, sets forth the reimbursement rates and billing procedures. This rule is being amended to comply with the forthcoming implementation of ODJFS Medicaid Information Technology Systems (MITS). Changes to the rule include this addition to paragraph (F) "Claims shall be submitted to, and reimbursement shall be provided by, the Ohio department of job and family services in accordance with Chapter 5101:3-1 of the Administrative Code" and deletion of this language in paragraph (F) "Reimbursement will be
