Rule 5101:3-1-17.2, entitled Provider agreement for providers [except long-term care nursing facilities and Medicaid contracting managed care plans (MCPs)], is being proposed for amendment in order to maintain consistency with the rules for the implementation of the expansion of Medicaid consumer co-payments effective on January 1, 2006. This rule sets forth Medicaid policy regarding Medicaid provider agreements. A valid provider agreement with Medicaid will act as a provider agreement for participation in the Medicaid and/or the Disability Medical Assistance programs. The change to the rule is changing the rule reference on Medicaid consumer co-payment policy from rule 5101:3-9-09 to rule 5101:3-1-09. This revision reflects the expansion of Medicaid co-payments from pharmacy services requiring prior authorization (PA) to certain pharmacy services that do not require PA, dental services, certain vision services, and non-emergency emergency room services as set forth in rule 5101:3-1-09.

Rule 5101:3-1-29, entitled Medicaid fraud, waste and abuse, is being proposed for amendment in order to maintain consistency with the rules for the implementation of the expansion of Medicaid consumer co-payments effective on January 1, 2006. This rule sets forth Medicaid policy regarding fraud, waste and abuse of medical services in the Medicaid program. The change to the rule is changing the rule reference on Medicaid consumer co-payment policy from rule 5101:3-9-09 to rule 5101:3-1-09. This revision reflects the expansion of Medicaid co-payments from pharmacy services requiring prior authorization (PA) to certain pharmacy services that do not require PA, dental services, certain vision services, and non-emergency emergency room services as set forth in rule 5101:3-1-09.
