Pursuant to section 5101.54 and Chapter 119 of the Ohio Revised Code, the director of the Ohio Department of Job and Family Services gives notice of the department's intent to consider the amendment of the rules as identified below and of a public hearing thereon.

Rule 5101:4-3-11, entitled "Food stamps: exemptions, work registration, work requirements, and sanctions," is being proposed for amendment to comply with the five year rule review as required in Ohio Revised Code 119.032. This rule sets forth exemptions from food stamp work registration, work registration procedures, work requirements, and sanctions for assistance groups in which all members are not eligible to receive benefits under Ohio Works First. There are no changes to this rule that affect the eligibility of applicants/recipients or how any county agency will administer the program.

Rule 5101:4-3-19, entitled "Food stamps: voluntary quit and reduction of work effort," is being proposed for amendment to comply with the five year rule review as required in Ohio Revised Code 119.032. This rule sets forth the criteria for establishing a voluntary job quit and reduction of work effort and the corresponding sanction to applied to the individual who meets the criteria. There are no changes to this rule that affect the eligibility of applicants/recipients or how any county agency will administer the program.

Rule 5101:4-3-29, entitled "Food stamps: employment and training (FSET): appraisal," is being proposed for amendment to comply with the five year rule review as required in Ohio Revised Code 119.032. This rule sets forth the criteria for appraising/assessing mandatory work registrants and developing employability plans to achieve self-sufficiency. There are no changes to this rule that affect the eligibility of applicants/recipients or how any county agency will administer the program.

Rule 5101:4-3-31, entitled "Food stamp employment and training: required hours," is being proposed for amendment to comply with the five year rule review as required in Ohio Revised Code 119.032. This rule sets forth the number of hours needed for each work component for participants to meet the work requirement. There are no changes to this rule that affect the eligibility of applicants/recipients or how any county agency will administer the program.

Rule 5101:4-3-32, entitled "Food stamp employment and training: supportive services," is being proposed for amendment to comply with the five year rule review as required in Ohio Revised Code 119.032. This rule sets forth the supportive services that county

agencies must provide to individuals who are subject to participation in the work requirements. There are no changes to this rule that affect the eligibility of applicants/recipients or how any county agency will administer the program.
