As part of the merger of the Ohio Department of Mental Health (ODMH) and the Ohio Department Alcohol and Drug Addiction Services (ODADAS), the Department of Mental Health and Addiction Services (MHAS) is combining and updating the definitions of services provided by certified service providers. As part of this process MHAS has focused on updating content to be consistent with current practice and wherever practical remove the distinctions between mental health (MH) and alcohol and other drug services (AOD)/substance use disorder (SUD).

The public hearing will be held May 17, 2017 at 9:00 a.m., in Room 3602 of the Rhodes State Office Tower located at 30 East Broad Street, Columbus, Ohio 43215, 36<sup>th</sup> Floor. At this hearing, OhioMHAS will accept verbal and written testimony on the rules under consideration.

The hearing will be conducted in accordance with Chapter 119 of the Revised Code. Any person affected by the rules may appear and be heard in person, by his attorney, or both, may present his position, arguments, or contentions, orally or in writing, offer and examine

witnesses, and present evidence tending to show that the rules, if adopted or effectuated, will be unreasonable or unlawful.
