Pursuant to section 5167.02 and Chapter 119. of the Revised Code, the director of the Ohio Department of Medicaid (ODM) gives notice of the Department's intent to consider the amendment, rescission, or adoption of the rules identified below and of a public hearing thereon.

**5160-58-01 "MyCare Ohio plans: definitions"** is being proposed for rescission and adoption as new to update policy related to the administration of the Medicaid managed care program. This rule sets forth the definitions used in Ohio Administrative Code (OAC) Chapter 5160-58 regarding the MyCare Ohio managed care program. Changes to this rule include the removal of duplicative definitions and acronyms to streamline the rule. Definitions were updated to reflect changes throughout Chapter 5160-58 of the OAC. OAC rule references were updated to reflect current Agency 5160 rules. United States Code (U.S.C) and Code of Federal Regulations (C.F.R) references were also updated. General edits were made for grammar, alphabetizing and formatting.

**5160-58-01.1 "MyCare Ohio plans: application of general managed care rules"** is being proposed for amendment to update policy related to the administration of the Medicaid managed care program. This rule sets forth the requirements for the MyCare Ohio program to follow the Medicaid managed care program rules outlined in OAC Chapter 5160-26. OAC rule references were updated to reflect current Agency 5160 rules. U.S.C and C.F.R references were also updated. General edits were made for grammar and formatting.

**5160-58-04 "MyCare Ohio HCBS Waiver Program Covered Services and Providers"** is being proposed for amendment to update policy related to the administration of the Medicaid managed care program. This rule sets forth the services available to managed care members who are enrolled in the MyCare Ohio home and community-based services (HCBS) waiver. The shared living service has been added to the listing of MyCare Ohio HCBS waiver program covered services. OAC rule references were updated to reflect current Agency 5160 rules. General edits were made for grammar and formatting.
