Following the June 28, 2018 public hearing on proposed rule amendments, the Commission placed all of its Original Filed rule amendments into To Be Refiled status.

Counsel for the Commission met with counsel for the Division of Oil & Gas Resources Management, and with an Assistant Attorney General, in order to discuss the suggested revisions.

Where appropriate, suggested revisions will be incorporated into the rules. Regarding some suggestioned revisions, after discussion, all parties agreed that certain revisions were not necessary.

Suggested revisions to three separate rules address the Commission's creation of an independent web site, as opposed to utilizing a web page created and managed by ODNR on behalf of the Commission. In the past, the Commission has explored creating its own web presence and has been discouraged in this regard by ODNR. However, the Commission intends to again approach ODNR communications in order to determine if ODNR would support the Commission's creation of a separate web site.

The Commission members will be reviewing all suggested revisions during a regularly-scheduled meeting on August 13, 2018. Thereafter, the rules will be revised and refiled.
