Consolidated Summary of Comments Received

1501:47-3-98, 1501:47-3-37 (Forked Run)

There was no testimony at the public hearing; all comments received before and after the public hearing were in support of rescinding the temporary rule allowing watercraft powered by more than 10 horsepower to operate on the waters of Forked Run at no-wake speed and making the provisions permanent through the amendment of 1501:47-3-37. Commenters cited increased safety, no need to purchase additional & expensive equipment, and providing lake access to more boaters.

1501:47-3-97, 1501:47-3-17 (Madison Lake)

There was no testimony at the public hearing; all comments received before and after the public hearing were in support of allowing any type of motorized watercraft to operate at nowake speed on the waters of Madison Lake and removing the electric-motor-only restriction for a pilot period of two years.

1501:47-3-97, 1501:47-3-17 (Belmont Lake)

Preliminary stakeholder feedback gathered before filing the rule amendments indicated that 80% of respondents were in support of the proposal. During the comment period after filing the rule changes, the level of support from all commenters fell to approximately 23%. There was no testimony regarding Belmont Lake at the public hearing; all comments were received at a local open house event, by email, and through other written correspondence. Commenters cited concerns with user conflict (canoes, kayak, and paddleboards vs. large motor boats), disruption of wildlife / destruction of habitat, noise, and potential pollution resulting from the presence of gasoline and oil utilized by combustion engines.

Rules 1501:47-3-97 and 1501:47-3-17 were revised, removing Belmont Lake from the list of water areas temporarily allowing any type of watercraft to operate at no-wake speed and reinstating the provision specifying that only electric motors are permitted on the lake.
